SEDERUNT

Rev Ken Gray, Moderator, with 37 ministers, 51 elders, 3 deacons and 10 corresponding members, as recorded separately.

APOLOGIES

Apologies were received from 10 ministers, 8 elders, 2 deacons and 1 corresponding member, as recorded separately.

MINUTES

VACANCY PROCEDURE COMMITTEE

Rev Alan Sorensen, Convener, presented the report of the Vacancy Procedure Report and the following deliverance was approved:

Rev Alan Birss presented the report of the World Mission & Ecumenical Relations Committee and the following deliverance was approved:

STEWARDSHIP & FINANCE

In the absence of Mr Peter Bennett, Convener, Rev Alistair Cook presented the report of the Stewardship & Finance Committee and the following deliverance was approved:

Presbytery:

- 1. Receives the Report
- 2. Notes that, in accordance with the instruction from Presbytery, the Finance Committee of Paisley Abbey has submitted a detailed plan to generate income and reduce costs to address the projected shortfall in their 2014 general funds budget to the Stewardship and Finance Committee.
- 3. Notes that 4 congregations with 2013 Ministry and Mission payments advised as still outstanding by the Church of Scotland General Treasurer's Department have been asked to provide the Stewardship and Finance Department with an up to date status on the settlement of the debt and confirmation that their 2014 Ministry and Mission payments are being paid on time.

PROPERTY

Mr William Mathieson, Convener, presented the report of the Property Committee and the following deliverance was approved:

Presbytery:

- 1. receives the report;
- a) notes that the Paisley: Glenburn manse has been inspected and found to be ready for occupation;
 - b) approves the resiting of Paisley: Glenburn's war memorial in accordance with the recommendation of the General Trustees' Fabric Committee;
- 3. approves the next stage of the upgrade programme at Greenock: Lyle Kirk's Newark Street building, which involves:

phase 1 of the proposed heating upgrade, costing circa £10,000 lighting upgrade, circa £6,000 fire alarm, circa £2,000 external notice boards (3), circa £5,000 phase 1 of architect's fees, circa £5,000 external works, circa £20,000 organ replacement, circa £45,000.

All estimates exclude VAT, and funds are available;

- 4. approves in principle the proposed upgrade to the heating system in Johnstone: St. Andrew's Trinity's church and halls, subject to the approval of the General Trustees' Fabric Committee and the advice of the Church of Scotland's heating consultant being obtained. The cost is estimated at around £15,000, and the funding is available;
- 5. a) notes that the Elderslie congregation has invited tenders from appropriate contractors for the construction of their proposed new halls development, following advice from the General Trustees' Fabric Committee's Assistant Secretary;
 - b) approves the Elderslie congregation's application to the General Trustees' Fabric Committee for grant assistance in the sum of £10,000 towards the total estimated cost of the project of £688,602;
- 6. instructs those congregations whose representatives were advised at the inspection of property records that their supplied information was incomplete to ensure that the missing details are provided to the Property Committee Convener as soon as possible;
- 7. approves the conversion of part of the double garage at the Paisley: Stow Brae manse to form a study at a cost of £15,000, including VAT;

8. instructs the Property Committee to obtain tenders for the 2014 quinquennial inspections at Neilston, Barrhead: St. Andrew's & Bourock, Paisley: Glenburn & Sherwood Greenlaw, Johnstone: High, St. Andrew's Trinity & St. Paul's, Linwood, Kilmacolm: Old & St. Columba's, and Port Glasgow: Hamilton Bardrainney, St. Andrew's & St. Martin's, and to report the result of the tendering process in due course.

MISSION & DISCIPLESHIP

Rev Eileen Ross, Convener, presented the report of the Mission & Discipleship Committee and the following deliverance was approved:

Presbytery:

- 1. Receives the report;
- 2. Notes the forthcoming dates for Safeguarding training and instructs presbyters to make these known and encourage take up by those who are eligible and have not yet attended training.
